LETTER TO VENDORS

This letter is being sent to ALL vendors who have participated in the past, or are considering participating in the 2019 Florida Gulf Coast Cluster.

The following is a list of the requirements that will be enforced for the 2019 shows with **"NO EXCEPTIONS"**.

All accepted Vendors SHALL have all monies owed, paid in full before being allowed to set up their booth. **"NO EXCEPTIONS"**

If payment is not received in full by 12/01/2018, there will be no guarantee of a particular space, as the spaces will be filled on a paid-in-full basis starting 12/02/2018. This is necessary due to the preparations for the show.

There will be **NO refunds** FOR VENDORS OR RV SPACES after December 1, 2018.

Times will be designated to restock your booth and will be enforced. If you have very large deliveries to the park, (Semi-Trucks) we suggest the deliveries be made later in the afternoon. If you have clients coming to pick up product, your clients **WILL** be expected to pay to enter the park. **NO EXCEPTIONS.**

Clients may only park behind your booth for loading and will have a maximum of 15 minutes.

If you work from a trailer and it is part of your booth, you **MUST** rent a space large enough to include the tongue of the trailer.

Several vendors rent tents (ALL EVENT TENT RENTAL) that are set up the week prior to the shows. Your space will **NOT** be reassigned once it is assigned. Be prepared and arrive early enough and have the correct means to set up your booth. While we will make every effort to accommodate all, your space could be between 2 of the preset tents. The tents **CANNOT** be moved and there might not be any other spaces available.

All vendors agree to be packed up, cleaned up and off the property by 12:00 NOON on Tuesday after the first cluster (Vendors only staying the first week) and by 12:00 NOON on Monday after the second cluster (for Vendors staying the second cluster or for both clusters). You will be charged for another day if you stay past 12:00 NOON.

A fire extinguisher is required in each booth.

These guidelines have been set in order to make this event the most convenient for all involved and to prevent any traffic jams or road blockages.
